2	Included in differential pay: Longevity premium, word procesing premium, bilingual pay and specialty department pay all calculated at a flat rate per pay period. In addition there are other premiums: Realtime pay, supervisory differential, acting assignment pay, night shift, mediator licensing and the 2 additional days pay for management cited below. All of these other premiums are based on a percentage of pay. All premiums have been included in the total annual compensation.

Benefits Worksheets	
1	Example: Retirement contributions include pension obligation bonds or certificates of participation.
2	The increase in employer contributions from last year did not change the benefit it is the required contribution by the county SFERS.
3	
4	
Salary Increase Worksheet	
1	Example: Dates of negotiated salary increases and salary increases that will come into effect after July 1, 2010.
2	The 0.77% increase is not a base wage increase, but instead it is the equivalent of 2 days pay, paid on 12/1/10 in lieu of a SAL increase.
3	The 2% increase is an additional salary step for all Court Reporters with at least 10 years of experience, which is almost all of them.
