Street



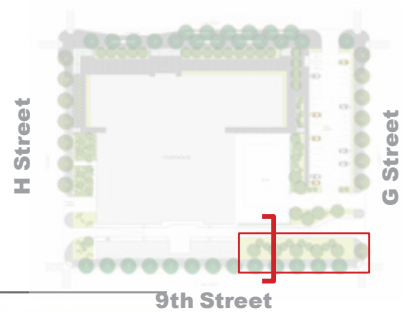
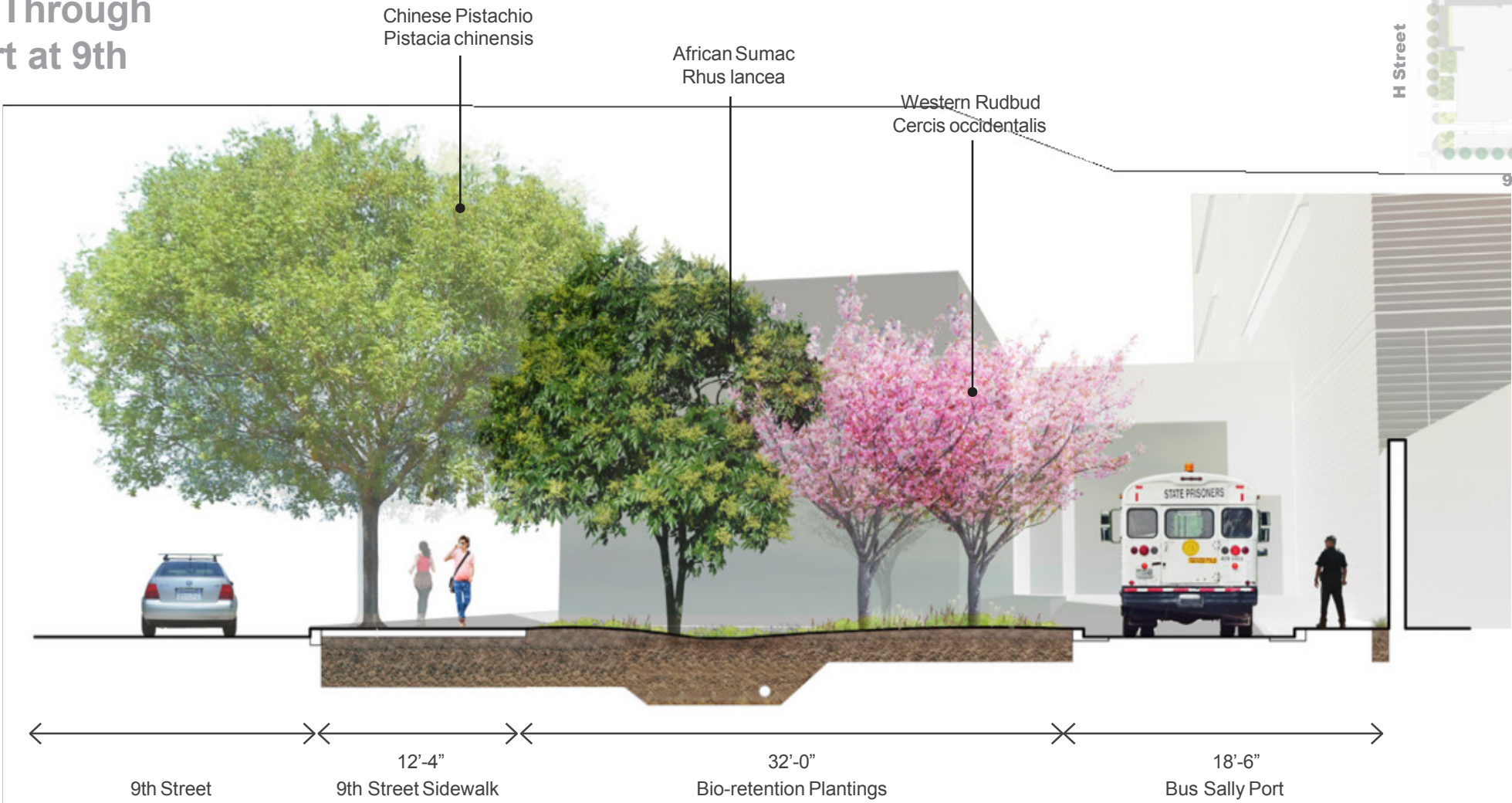

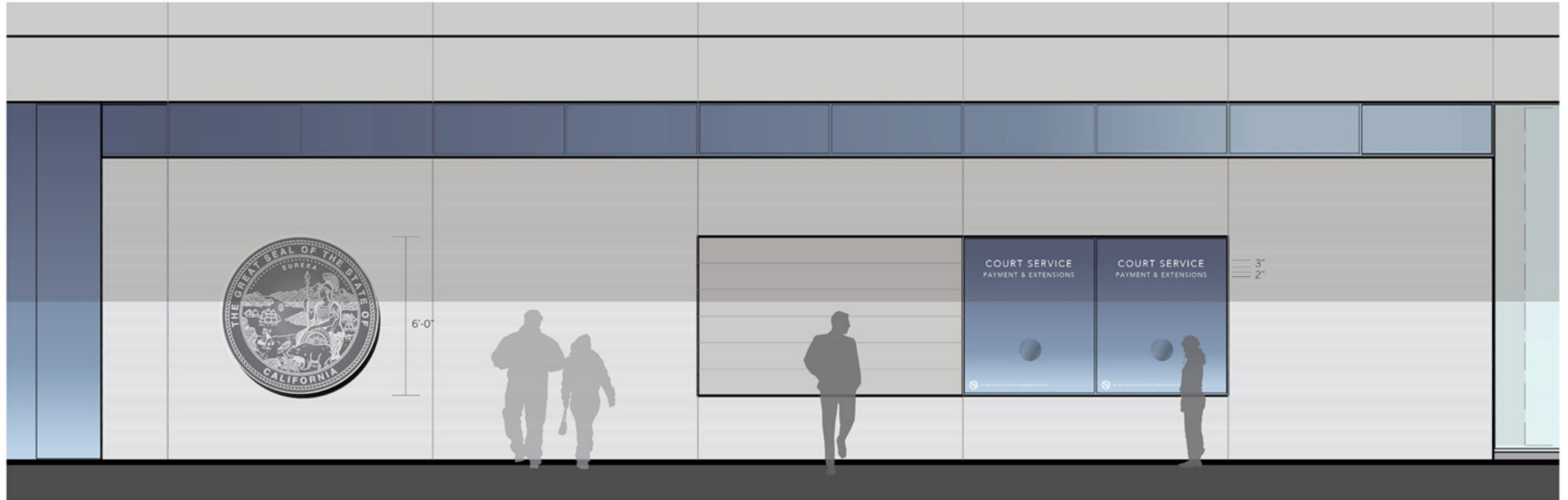

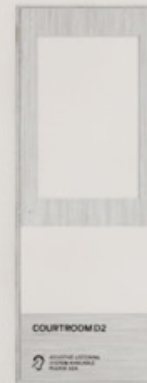

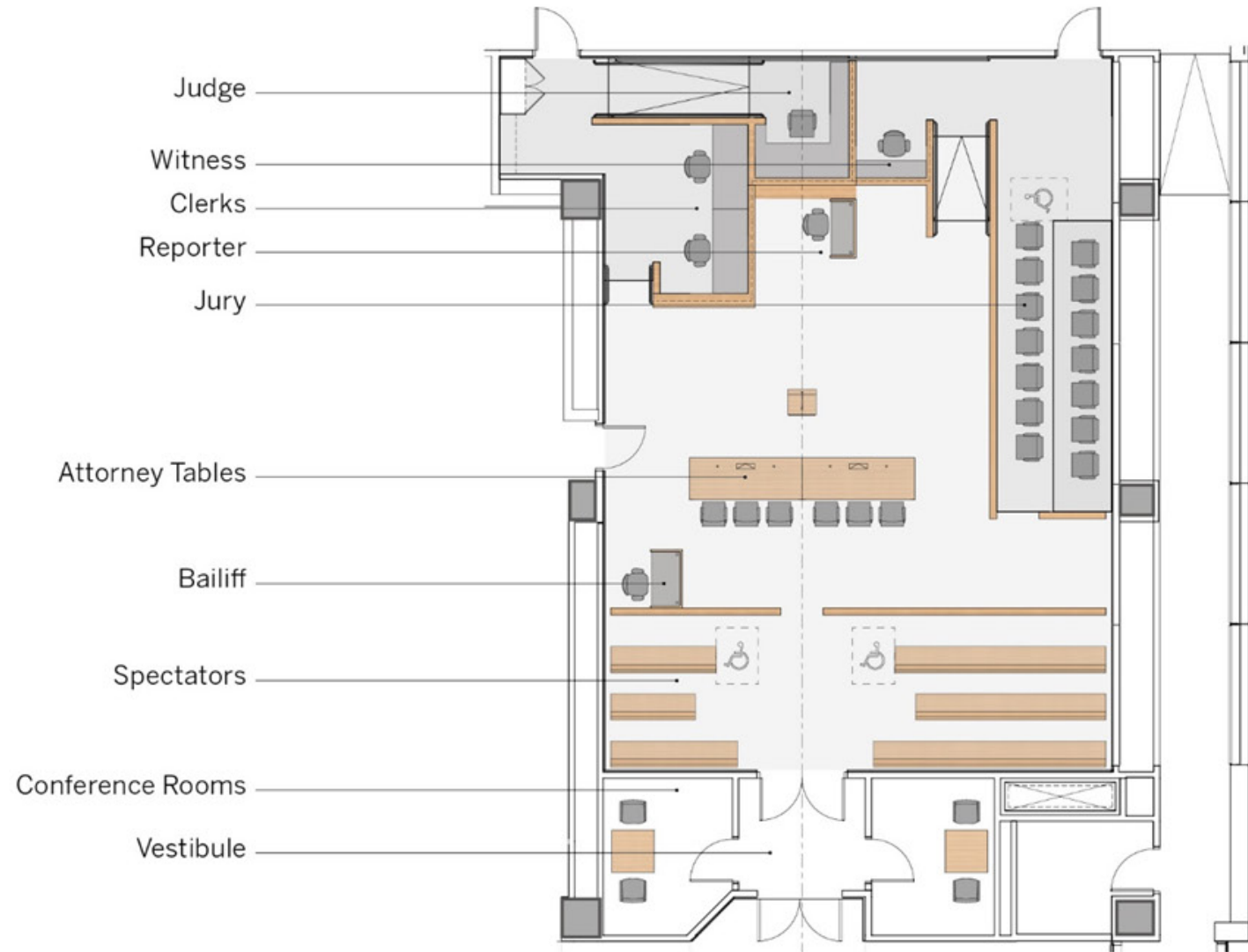
