Issue

The San Bernardino and Riverside Superior Courts are requesting to continue to receive CWR funds during the unforeseen temporary closure of their children's waiting rooms in response to the COVID-19 pandemic. By continuing to receive CWR funds, these courts will have sufficient resources to help defray costs when resuming operations.

Background

Per Government Code (GC) section 70640, it is the policy of the state that courts shall endeavor to provide a CWR in each courthouse for children whose parents or guardians are attending a court hearing or for other court purposes. After January 1, 2006, a court may apply to the Judicial Council for a CWR distribution between \$2 and \$5, inclusive, from applicable filing fees (see Attachment A) to help cover the costs of operating CWRs.

Per Judicial Council approval of the Trial Court Budget Advisory Committee-recommended CWR policy revisions at its business meeting on July 24, 2020¹, the Fiscal Planning Subcommittee makes a recommendation directly to the council on a court's request.

San Bernardino Superior Court

San Bernardino Superior Court's request for a continued CWR distribution is provided in Attachment B. On March 17, 2020, the court received Chief Justice Cantil-Sakauye's approval of its emergency order to close except for limited emergency matters, and another extension of this order was approved on April 28, 2020. The emergency order included closure of its CWRs effective March 17, 2020. Due to continued health and safety concerns for court staff and the public, the court does not plan to reopen its CWR locations until it is deemed safe, which may be later in the summer of 2020.

Riverside Superior Court

Riverside Superior Court's request for a continued CWR distribution is provided in Attachment C. Due to the COVID-19 pandemic and its impact on court operations, the court closed all CWR

locations, two locations effective March 20, 2020 and four locations effective April 1, 2020. The court reopened four of its six CWRs on June 15, 2020. The court continues to closely monitor the evolving pandemic situation and hopes to reopen the remaining two locations by the end of calendar year 2020.

Attachment D provides the total distributions for 2016-17, 2017-18, 2018-19, and 2019-20 for the 18 courts that currently have a CWR distribution.

Attachments E and F provide the distribution from the First Paper General Civil Unlimited Uniform Filing Fee (GC 70611) for San Bernardino and Riverside Superior Courts, respectively. There is no change in the distribution for these requests because the two courts are already receiving a CWR distribution.

Recommendation

Approve a recommendation for consideration by the Judicial Council at its business meeting on September 25, 2020 to approve the continued distribution of CWR funds to the San Bernardino and Riverside Superior Courts to allow each court to receive funding to defray costs and support operation of CWRs upon reopening.

Government Code Section 70640

- (a) It is the policy of the state that each court shall endeavor to provide a children's waiting room in each courthouse for children whose parents or guardians are attending a court hearing as a litigant, witness, or for other court purposes as determined by the court. To defray that expense, monthly allocations for children's waiting rooms shall be added to the monthly apportionment under subdivision (a) of Section 68085 for each court where a children's waiting room has been established or where the court has elected to establish that service.
- (b) The amount allocated to each court under this section shall be equal to the following: for each first paper filing fee as provided under Section 70611, 70612, 70613, 70614, or 70670, and each first paper or petition filing fee in a probate matter as provided under Section 70650, 70651, 70652, 70653, 70654, 70655, 70656, or 70658, the same amount as was required to be collected as of December 31, 2005, to the Children's Waiting Room Fund under former Section 26826.3 in the county in which the court is located when a fee was collected for the filing of a first paper in a civil action under former Section 26820.4.
- (c) Notwithstanding any other provision of law, the court may make expenditures from these allocations in payment of any cost, excluding capital outlay, related to the establishment and maintenance of the children's waiting room, including personnel, heat, light, telephone, security, rental of space, furnishings, toys, books, or any other item in connection with the operation of a children's waiting room.
- (d) If, as of January 1, 2006, there is a Children's Waiting Room Fund in the county treasury established under former Section 26826.3, the county immediately shall transfer the moneys in that fund to the court's operations fund as a restricted fund. By February 15, 2006, the county shall provide an accounting of the fund to the Administrative Office of the Courts.
- (e) After January 1, 2006, the court may apply to the Judicial Council for an adjustment of the amount distributed to the fund for each uniform filing fee. A court that wishes to establish a children's waiting room, and does not yet have a distribution under this section, may apply to the Judicial Council for a distribution. Applications under this subdivision shall be made according to trial court financial policies and procedures authorized by the Judicial Council under subdivision (a) of Section 77206. Adjustments and new distributions shall be effective January 1 or July 1 of any year beginning January 1, 2006.
- (f) The distribution to a court under this section per each filing fee shall be not less than two dollars (\$2) and not more than five dollars (\$5).

Notice of Temporary Closure of Children's Waiting Rooms

To: Director of Budget Services

The Superior Court of San Bernardino (Court) is writing to provide official notice as required per the Children's Waiting Room Policy that all of the Court's waiting rooms temporarily closed effective March 17, 2020, in response to the COVID-19 pandemic.

The Court received Chief Justice Tani Cantil-Sakauye's approval of its emergency order to close with the exception of limited emergency matters on March 17, 2020, and another extension of this order was approved on April 28, 2020.

At the time of this notice, due to continued health and safety concerns, the Court does not plan to reopen its children's waiting room locations until it is deemed safe, which may be later in the summer. During the temporary closure, the Court respectfully requests to continue to receive distributions and will follow all required accounting measures for the safe-keeping of these funds.

Please also note the Court requested clarification of this policy on April 1, 2020, and received an official response requiring notice on May 7, 2020.

Dear Mr. Wordlaw, John -

Due to the COVID-19 coronavirus pandemic and its impact on court operations, the court temporarily closed its CWRs at the Riverside Family Law and Hemet Courthouses beginning March 20, 2020. The court also temporarily closed its CWRs at the Larson Justice Center, Southwest Justice Center, Southwest Juvenile Courthouse, and Riverside Juvenile Courthouse beginning April 1, 2020.

The court is requesting that the Judicial Council consider its request to continue receiving CWR distributions during the temporary closure of these CWRs.

The court has since re-opened the CWRs at the Larson Justice Center, Southwest Justice Center, Southwest Juvenile Courthouse, and Riverside Juvenile Courthouse on June 15, 2020.

The court continues to closely monitor the evolving COVID-19 coronavirus situation and hopes to re-open the CWRs at the Riverside Family Law and Hemet Courthouses by the end of calendar year 2020.
