DISCUSSION AND ACTION ITEMS (ITEMS 1-2)

Item 1

Rule Proposal Sponsored by the TCPJAC and CEAC

Judge Carolyn B. Kuhl, Co-Chair TCPJAC/CEAC Joint Rules Subcommittee, presented a draft rule proposal for Rule 10.620 (Trial Court Management: Public Access to Administrative Decisions of Trial Courts) for TCPJAC to consider co-sponsoring with the Court Executives Advisory Committee (CEAC) and submitting to the Judicial Council's Rules and Projects Committee for its consideration to include in the Spring 2015 rules cycle.

Action:

A motion was made (Coleman) and seconded (Hopp) that TCPJAC, together with the Court Executive Advisory Committee (CEAC), propose amendments to Rule 10.620 (Trial Court Management: Public Access to Administrative Decisions of Trial Courts) and that the amendment be submitted to the Judicial Council's Rules and Projects Committee for its consideration to include in the Spring 2015 rules cycle. Item 2

Discussion on Possible Amendments to Penal Code 808

TCPJAC Executive Committee member Hon. Donald D. Coleman (Ventura), asked members for feedback on whether the TCPJAC would want to consider recommending that the Judicial Council sponsor legislation to amend Penal Code 808 to add commissioners in the definition of "Magistrate".

Action: *Motion made (Anderson) and seconded (Pichon) that TCPJAC request Judicial Council's legal services to review and investigate the implications of amending Penal Code 808 and, if feasible, that the project to be incorporated in the TCPJAC 2016 Annual Agenda. Motion passed unanimously.*
