Summary of Cases Accepted and Related Actions During Week of October 14, 2019

#19-163 *People v. Alexander, S257190.* (A151809. A152247; 36 Cal.App.5th 827; San Francisco County Superior Court; SCN220303.) Petition for review after the Court of Appeal remanded in part and otherwise affirmed judgments of conviction of criminal offenses. The court ordered briefing deferred pending decision in *People v. Stamps*, S255843 (#19-63), which presents the following issue: Is a certificate of probable cause required for a defendant to challenge a negotiated sentence based on a subsequent ameliorative, retroactive change in the law?

The court's primary role is to decide matters of statewide importance and to maintain uniformity in the law throughout California by reviewing matters from the six districts of the California Courts of Appeal and the fifty-eight county superior courts (the trial courts). Among its other duties, the court also decides all capital appeals and related matters and reviews both attorney and judicial disciplinary matters.
