

# WHAT DOES THE MEDIATOR DO?



## A Mediator :

- Does not force the Parties to agree.
- Helps the Parties communicate.
- The Parties themselves settle the dispute.
- Leaves the control of the outcome with the Parties.

**There is an alternative to resolve your dispute.**

**Mediation is an informal alternative to litigation.**

- Mediation may solve your dispute far quicker than a lawsuit.
- Mediation is private, while a lawsuit is a public event.
- The Parties themselves control the process and the solution.
- Mediation is a voluntary process.
- Any statements or proposals for settlement made in mediation are confidential.
- It is an impartial procedure. The mediator cannot favor one party's interest over the other.
- The solution to the dispute on a written agreement signed by both Parties is enforceable in a court of law.
- If you participate in mediation and no agreement is reached, you can still file a lawsuit.

Mediation is a voluntary process designed to bring parties to a conflict together in a safe environment for a face-to-face meeting to work out a solution to the dispute that brought them to Court. Resolutions are based on the voluntary choice of the parties.
