5. History of California Law Librarians' Online Chat Reference Service

AskNow / QuestionPoint

California Law Librarians' Online Chat Reference Service

History of the Project

September 2001	CCCLL voted to participate as law reference experts for the 24/7 Reference program of the Metropolitan Cooperative Library System.
January 2002	Law Librarians began answering targeted legal information questions for AskNow, California's online chat reference service.
December 2002	Law Librarians were answering about 100 questions per month, live and via email. Most questions were live sessions transferred to law librarians by the public library staff.
January 2, 2003	California Courts Self-Help Center website added an "Ask the Law Librarian" link to navigation bar of every page on the site. The number of questions rose from about 5 per day to 5 per hour.
August 2004	24/7 Reference, the chat software used by AskNow, was purchased by OCLC.
October 2005	AskNow began using OCLC's hybrid software, QuestionPoint:24/7.
March 2006	QuestionPoint software, originally HTML based, converted to a flash-based program.

Statistics

December 2002	The Law Librarians handled 100 questions per month, via live chat and email.
2003	During the first nine months of the year, the Law Librarians received an average of 1000 chats per month, but 11.5% were abandoned before the Librarian could answer them.
2004	The Law Librarians consistently handled 290-295 live chats per week.
2005	The Law Librarians received over 16,400 questions, including 600 e-mail responses in 2005. Approximately 1366 questions were answered per month. The chat reference service had an approval rate of over 82%.
2006	The Law Librarians chatted with 6542 users, and answered 4515 emailed reference questions. Approximately 921 questions were answered per month.

www.lawhelpcalifornia.org – self-help oriented documents and websites for the self-represented.

www.nolo.com – the publisher of popular self-help guides found in most law libraries, their website has excellent content.

If these do not answer your questions, it may be that you are asking something requiring more detailed explanation or interpretation that will require the work of an attorney, the court staff or our own time spent in the law library. Find the website, or the location and hours of your county’s law library at www.publiclawlibrary.org.


One of the law library’s main purposes is to make available to the public in one central place the research materials that will help people find answers to their questions about the law and legal procedure.

GETTING STARTED

Thank you for using our virtual reference service. Your question was transferred to a law librarian for email assistance. The law librarians can recommend and refer you to online and print resources that will help you find answers to your law-related questions, but we cannot explain or interpret the law itself, or give legal advice.

When trying to get a divorce, if you do not plan to employ an attorney, we recommend that you talk with your local family law facilitator. Every court in California has a lawyer that will help you with family law problems for free. These lawyers are called "family law facilitators." The facilitators can't represent you in court, but they can help in other ways. In some counties, they show people how to fill out court forms. They can give you brochures about family law and tell you about other places to get help, like lawyer referral services, legal aid clinics, and self-help law centers. To find your family law facilitator, go to <http://www.courtinfo.ca.gov/selfhelp/lowcost/ff.htm>.

You may want to look at a book called "How to Do Your Own Divorce in CA," written by Attorney Ed Sherman, and published by Nolo Press. This book will take you step by step through the process of getting divorced, including providing forms and sample instructions. This book is available at large bookstores, large libraries, directly from the publisher's website at www.nolo.com and from your local public law library.
