# **Budget and Program Priorities for FY 2014-15**

Clerk's Office in Solvang to close in 2014 ● Santa Barbara Juvenile Court to be closed and consolidated into other facilities ● Traffic Night Court cut 50% in Santa Maria ● Civil default judgments take over 5 months to complete

## Self-Help / Mediation / Facilitator Services

- Self-help services to the community have been slashed due to funding reductions.
- Child custody mediations that took 3 weeks to schedule have been extended to 5 weeks in FY 2013-14.

#### Counters / Clerks / Telephones

- Default dissolutions once taking 7 days to complete now require over 6 weeks to complete.
- Public counters that closed at 4:30pm in FY 2007-08 now close at 3:00 pm daily.

#### **Closed Courtrooms in Solvang and Juvenile**

- Small claims filings eliminated at the Solvang Courthouse.
   Litigants must get help at other courts.
- Solvang Court will be reduced to hearing traffic matters one day per month and the clerk's office closed.
- The Juvenile Court in Goleta will be closed and matters transferred to downtown Santa Barbara. Juvenile detention hearings may be conducted via remote video from the juvenile hall located 75 miles to the north.

#### Staff Impacts / Furloughs / Layoffs / Unfilled Vacancies

- 41 full-time staff positions reduced since FY 2007-2008 through attrition and voluntary separation program.
- Both Assistant Executive Officer positions have been eliminated along with Executive Administrative Support.
- There is over a 15% vacancy factor.
- Inadequately trained extra help cover some vacancies on a part time basis.

## Court Security / Safety / Facilities

- The Historic Courthouse has no perimeter security screening for volatile family law and small claims matters.
- · Inmates are escorted through public areas.

## **Availability of Judicial Officers**

Commissioner position has been frozen forcing consolidation of traffic, and severely limiting services to restorative and therapeutic justice courts.
