3/98	Hired two court clerks, one for each site
6/98	Hired additional attorney and additional clerk to staff a third site, Family Court, also in downtown San Diego. Services to be provided included help with divorces, separations, civil parentage actions (not IV-D), child custody, visitation, and other simple family law issues
9/99	Hired two attorneys and one clerk to staff three additional locations, one to assist with domestic violence restraining orders at the Family Law Annex, and one to split time between an east county location (El Cajon courthouse) and a south county location (Chula Vista courthouse). Services at the El Cajon courthouse and Chula Vista courthouse were to include general family law issues. Subsequently all domestic violence restraining orders at the Family Law Annex were taken over by agreement with the San Diego Volunteer Lawyer Association
	FLF partnered with Legal Aid under a State Bar grant. Legal Aid provided a bilingual attorney at the Chula Vista courthouse and the Court supplied a bilingual clerk. The Legal Aid attorney assisted customers on the days the FLF attorney was not present, but under Legal Aid income guidelines.

Status conference hearings went into effect the summer of 2002, first at the Family Court location, followed by Vista, El Cajon, and then

Chula Vista.

5/03 Hired additional bilingual clerk for Family Court

4 attorneys, 2 paralegals, 1 clerk - Vista court

6 attorneys, 2 paralegals, 2 clerks - Family Court

2 attorneys, 2 paralegals, 1 clerk – IV-D site downtown

2 attorneys FT, 1 PT (3/5) attorney, 1 paralegal – El Cajon court

2 attorneys, 1 PT (2/5) atty, Legal Aid atty, 1 clerk – Chula Vista court

(We have since lost the Legal Aid attorney due to budget cuts)

Early 2004 Family Law Presiding Judge requests FLF staff the guardianship calendar one day per week at the Probate Court to help pro pers coming out of the courtroom with their orders and defects in pleadings.

12/05 Hired additional attorney to float between sites for coverage purposes

With continued increased staffing, the Facilitator's Office is able to assist the court with all the pro per status conference hearings (now called Case Classification Conferences as of 1/05), increase the number of divorce workshops conducted at various courthouse locations, including Spanish divorce workshops, prepare all Findings and Order after Hearings and Judgments for pro pers coming out the courtroom, handle judicial referrals on the spot, as well as provide staffing for the guardianship calendar requested by the Presiding Family Law Judge. We currently staff five locations full time (one IV-D only, four general family law issues) and staff the Guardianship Calendar at yet another location one day per week.
